Have the right to either an uninterrupted 24 hours clear of work each week or 48 hours clear of work each fortnight. Are entitled to a 20-minute rest break, if you work more than six hours in one shift and additional breaks may be given by your contract of employment. There is no statutory right to cigarette breaks.

Your rights in work | My World of Work Redundancy pay. If you have worked continuously for an employer for at least two years and you're being made redundant, you have the legal right to redundancy pay. You're also eligible if you have a fixed-term contract of two years or more that expires and is not renewed because of redundancy.
